REGULAR SCHOOL BOARD MEETING

May 18, 2015

- The Randolph School Board met in regular session on Monday, May 18, 2015, at 7:00 p.m. in the Media Center. Gary Moorhouse called the meeting to order. Directors present: Gary Moorhouse, Jay Otte, Sara Taylor, Cory Lorenzen, Garlan Dubbels, and Michael Kelley, Superintendent. Director absent: Steve Weidner. Administrators present: Benjamin Fisher and Regina Wernimont. Staff members present: Kathy Stauffer, Amy Burke, and Jackie Sczepanski. Guests: Alicia Ehleringer, Mackenzie Ehlers, Megan Peine, Evan Heather, Shaylee Bistodeau.
- 2) A motion to approve the agenda as established was made by Sara Taylor, seconded by Garlan Dubbels. All members voting in favor.

4) Amy Burke and Family Career Consumers Leadership of America (FCCLA) Members - Alicia Ehleringer, Mackenzie Ehlers, Megan Peine, Evan Heather, Shaylee Bistodeau - reported to the School Board about their program. Randolph School joined FCCLA Region 1 last school year with 7 students - this year the program has 16 students. Some of this year's highlights included results from the State Conference: Morgan Kohler received Gold in Recycle and Redesign; Alicia Ehleringer received Gold in Drama Driven; Shaylee Bistodeau and Evan Heather received Silver in Chapter Service with therapeutic animals; Megan Peine, Carley Mumm and Mackenzie Ehlers received a bronze in Chapter and Review. They had four national advancers - Morgan Kohler, Megan Peine, Carley Mumm and Mackenzie Ehlers. Megan and Mackenzie will be traveling to the nationals in Washington DC in July with Mrs. Burke. Parents Night Out has been a successful fundraiser for the group. They have also been outreaching with their program to Children's Hospitals, Women's Shelters, etc. FCCLA was formerly known as FHA (Future Homemakers of America) and the program is in its 70th year.

Jackie Sczepanski, along with students Mackenzie Ehlers and Alicia Ehleringer, reported on the Band Trip to Florida March 16 to March 21. The group favored flying this time vs the bus trip last time. Mrs. Sczepanski played a DVD of the trip. Highlights included Magic Kingdom, Disney's Hollywood Studios, Hardrock Cafe, Universal Studios, Animal Kingdom, Epcot, and Blue Man Group Performance.

BE IT RESOLVED by the School Board of Independent School District No. 195, State of Minnesota, as follows:

- 1. It is hereby found, determined and declared that the special election of the voters of this school district held on May 12, 2015, was in all respects duly and legally called and held.
- 2. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 620 voters of the school district voted on the question of authorizing the issuance of school building bonds for a school acquisition and betterment program (SCHOOL DISTRICT QUESTION 1), of which 284 voted in favor, 336 voted against the same, and there were 3 completely blank or defective ballots related to this question. Said proposition, having not received the approval of at least a majority of such votes, is hereby declared to have failed.

3. The clerk is hereby directed to certify the results of the election to the county auditors of each county in which the school district is located in whole or in part and to the Commissioner of Education.
