- The Randolph School Board met in regular session on Tuesday, January 21, 2020, at 6:00 p.m. in the Media Center. Gary Moorhouse called the meeting to order. * WHEREAS, the financial condition of the school district dictates that the school board must reduce expenditures immediately, and

** WHEREAS, there has been a reduction in student enrollment, and,

WHEREAS, this (reduction in expenditure*) and (decrease in student enrollment**) must include discontinuance of positions and discontinuance or curtailment of programs, and

WHEREAS, a determination must be made as to which teachers' contracts must be terminated and not renewed and which teachers may be placed on unrequested leave of absence without pay or fringe benefits in effecting discontinuance of positions,

BE IT RESOLVED, by the School Board of Independent School District No. 195, as follows:

That the School Board hereby directs the Superintendent of Schools and administration to consider the discontinuance of programs or positions (to effectuate economies in the school district and reduce expenditures*) and, (as a result of a reduction in enrollment**), make recommendations to the school board for the discontinuance of programs, curtailment of programs, discontinuance of positions or curtailment of positions.

- 10) A motion was made by Jason Podritz, seconded by Sara Taylor to approve the 2019-2020 Final Seniority List as presented by the administration. All members voting in favor.
- 11) The Administration reviewed the January 2020, K-12 student enrollment with the Board. Enrollment is up by 3 students from the start of this school year with a current total K-12 enrollment of 692, which is up 9 students from January 2019.
- 12) Matt Rutledge, Elementary School Principal, reported on math curriculum for grades 5 &6 will be more online; feedback on the therapy dog at school has been very positive.
- 13) Benjamin Fisher, High School Principal/Special Ed Director, reported Science Standards will be changing 2023-2024 school year; did a Crisis Prevention Intervention refresher course webinar and shared information with special education staff; Allison Wyatt has been approved to teach College in School Physics Inquiry course at Randolph School next year.
- 14) Aaron Soule, Assistant HS Principal/Activities Director reported Visual Arts, Speech and Knowledge Bowl have started; softball scoreboard is up and looks great; thanks to Jackie Sczepanski who has collected \$960.00, so far, for the Care Packages for Troops; on teacher workshop day the high school faculty provided bars and hot chocolate for the school construction workers.
- 15) Patty Riemenschneider, Business Manager, provided a Construction Investment Report from Ehlers - we have currently earned \$103,591.75 in interest on the construction funds; OSHA 2019 - we had zero reportable injuries.
- 16) Michael Kelley, Superintendent, reported on the new addition WiFi and furniture; Jaquar Phone System is up and running – we now have to dial 9 for an outside line; read information from Ehlers on the School Building Bond Agricultural Credit – Minnesota Statutes, section 273.1387; Pay Equity report has been submitted – this is done every three years.
- 17) School Board reported on the 100th MSBA Convention held January 16th and the Community Education Committee Meeting held on January 21st.
