- 6) The School Board recognized and thanked Vanda Pressnall for serving as a School Board Member of Intermediate School District 917, representing Randolph School for the past 20 years. Lisa Ehleringer has been appointed to take over for Vanda starting in July.
- 7) A motion was made by Jason Podritz, seconded by Leah Radman to present Arnold Felton an Honorary Degree from Randolph School. Arnold is the second Felton generation, of now six, that has attended Randolph School. In 1944 Arnold left school as a Junior and started farming. In 1960, Arnold was elected to the Randolph School Board with the most write-in votes to win a seat on the School Board. For 12 years, Arnold was Treasurer on the Randolph School Board from 1960-1972. In 1970 he represented Randolph School District to charter the now Dakota County Technical College in Rosemount. In 1971 the Randolph High School addition was constructed and completed during his tenure on the school board. Arnold has been a great asset to the Randolph Community. Well deserved.
