- The Randolph School Board met in regular session on Monday, May 19, 2014, at 7:00 p.m. in the Media Center. Gary Moorhouse called the meeting to order. Directors present: Gary Moorhouse, Jay Otte, Sara Taylor, Cory Lorenzen, Garlan Dubbels, and Michael Kelley, Superintendent. Director absent: Steve Weidner. Administrators present: Benjamin Fisher, Matt Rutledge and Regina Wernimont. Staff members present: Kathy Stauffer and Ed Terry. Guests: Cheyenne Weiland, Madison Taylor, Amber Shay, and Jackson Neil.
- 2) A motion to approve the agenda as established was made by Sara Taylor, seconded by Garlan Dubbels. All members voting in favor.
- 3) A motion was made by Jay Otte, seconded by Cory Lorenzen to approve the following consent agenda items:

- 4) Mr. Terry and FFA Members Cheyenne Weiland, Madison Taylor, Amber Shay and Jackson Neil reported to the School Board on the FFA Awards Program and State Convention. A few of the many highlights they talked about included: over \$16,500 in scholarships, raised over \$21,000 for Camp Courage (top in the state); tractor parade; CFI Grant; FFA Alumni is the largest group in the state with 150 members; and Mr. Terry thanked his wife, Carol Terry, for all her hard work behind the scenes helping to make the Randolph FFA Program such a success.

- 8) Benjamin Fisher, High School Principal, went over the 2014-2015 Master Schedule; the high school play "Grease"; Athlete Recognition Ceremony on May 15 honoring Ashleigh Dralle, Kelsey Jo Endres and Cody Pirkl who are going on to play sports in college.
- 9) Regina Wernimont, Business Manager, reported an increase in our health insurance renewal (12% increase for singles/13% increase for families); we will be changing our copier lease and printer management program from Xerox with MOTG to Cannon with Loffler on August 1st; gave an update on CTE Career & Tech Ed Revenue; and the legislative basic formula increased \$25.00 per pupil.
- 10) Michael Kelley, Superintendent, reported on summer plans; gym floors will be resurfaced July 21-25; septic system update; and our current projected enrollment for 2014-2015 is up 37 students primarily due to a senior class of 27 graduating and a kindergarten class entering of 59.
- The School Board reported on the Personnel Committee Meeting and Transportation Committee Meeting both held on May 19th.
